### **EXECUTIVE SUMMARY**

Central Academy for State Forest Service (CASFOS), Dehradun under the aegis of Directorate of Forest Education (DFE) Ministry of Environment, Forest and Climate Change, took a step ahead of its mandate and conducted two days (15.3.21 and 16.3.21) training programme for paramilitary personnel on the theme "Wildlife trade and Trafficking". The Ministry of Environment, Forest and Climate Change, Government of India sponsored for the 'Training of other stakeholders' and 'Personnel of Other services' on topics/themes related to Forestry, Wildlife, Environment Mangement, Administration and related issues. In this backdrop, training of Paramilitary personnel on the theme of 'Wildlife trade and Trafficking' was planned and organised. The training was conducted on virtual mode due to the current pandemic COVID-19 situation. More than 200 participants from 29 States of India participated with overwhelming enthusiasm in this training programme; which was the first of its kind.

The Course Director of the training, Dr. T. Beula Ezhil Mathi IFS, Lecturer, CASFOS gave a brief presentation about the course after which Mr. Kunal Satyarthi IFS, Prinicpal, CASFOS presented the opening remarks. In his opening remarks, he warmly welcomed the chief guest Mr Keshav kumar IPS DGP and Director ACB, Gujarat and all the participants of the training programme. He emphasized the role of paramilitary personnel in wildlife conservation of our country and expressed his belief that this training through sensitization of the personnel would achieve the goal of Environment Conservation. Chief guest of the training Mr Keshav Kumar reiterated the role of paramilitary personnel in curtailing the wildlife trade and importance of wildlife conservation. He further presented an interesting case study of wildlife trade from Gujarat through which he demonstrated the role of all stake holders in wildlife conservation and how the paramilitary personnel could help in conservation efforts.

Guest Speakers like Ms. Tilotama Varma IPS, Mr.S. P. Yadav IFS, Mr. G. S Bharadwaj IFS, Mr. Saket Badola IFS, etc alongwith in -house faculty Mr Kunal Satyarthi IFS deliberated on Wildlife trade and trafficking related topics in this training programme. The topics covered in this training were Overview of Wilflife trade and trafficking -India and world, Role of WCCB in wildlife trade and trafficking, Identification of wildlife

articles and trophies, Issues of Tiger conservation in India etc., The detailed time table showing session-wise topics and resource persons is enclosed as Annexure 5.

A total of 223 personnel from 29 states of India registered for the training out of which 190 personnel participated in the training programme. The training programme was very well appreciated by the participants who also requested for more of such training programmes regularly, for keeping up the momentum of wildlife conservation ideas. They also requested for local level trainings of personnel state-wise and inclusion of wildlife conservation in their training curriculam. The Participants also urged for offline training course through which they would gain practical experience.

A compendium of articles, presentations related to the relevant topics covered during the course, apart from the copies of the presentations made by the experts in each session were provided in soft copy to each trainee as part of the training kit through the Academy's website <a href="www.casfosddn.nic.in">www.casfosddn.nic.in</a> and also, through the SharePoint link provided to the participants, from where they could also download the recordings of all the sessions.
