



EXECUTIVE SUMMARY

The Ministry of Environment, Forest and Climate Change, Government of India sponsors the 'Training of Other Stakeholders' and 'Personnel of Other Services' on topics/themes related to Forestry, Wildlife, Environment and related issues. In this backdrop, Central Academy for State Forest Service (CASFOS), Dehradun under the aegis of Directorate of Forest Education (DFE) Ministry of Environment, Forest, and Climate Change, conducted three days (from 27.02.2023 to 01.03.2023) training program for "Tourism Development Corporations, Tourism Departments, Tour Operators, Resort & Home Stay Owners" on the theme "Operationalizing Successful Ecotourism".

The Course Director of the training, Mr. Amlendu Pathak, IFS, Lecturer, CASFOS, Dehradun gave a brief presentation about the course after which Mr. Pradeep Wahule, IFS, in-charge Principal, CASFOS, Dehradun presented the opening remarks He stated the importance of collective stakeholder approach in ecological conservation and livelihood generation for which, this very step to conduct training for other stakeholders is taken up by CASFOS. Chief Guest Mr. Rajiv Bhartari, IFS, PCCF & Chairman, Uttarakhand Biodiversity Board gave the inaugural address. In his inaugural speech, the Chief Guest mentioned about ecotourism being a business but having responsibility towards ecological conservation at the same time. He emphasized upon the importance of ecotourism in livelihood generation. Guest Speakers like Mr. Ajay Srivastava, IFS (Retd.) former PCCF & HoEF, HP, Mr. Sanjay Sondhi, Founder Trustee, TITLI Trust, Dr. A.K. Bhardwaj, IFS (Retd.) former PCCF & HoEF, Kerala, Mr. Bachi Singh Bisht, Bachhi Corbett Ramnagar, Uttarakhand, Mr. Mohan Chandra Pandey, Secretary, Corbett Gram Vikash Samiti, Mrs. Malika Virdi, Founder, Himalayan Ark, Munsyari deliberated on various topics related to Operationalizing Successful Ecotourism in this training program. The detailed timetable showing session-wise topics and resource persons is enclosed as Annexure-V.

Valedictory session was presided over by Chief Guest Dr. Ramana Athreya, Associate Professor, IISER, Pune during which an interactive session with the participants was also held. Dr. Athreya talked about the importance of Researchers, Tour Operators and Forest department working in a more synchronized manner to achieve the goals of Ecotourism.

A total of 24 participants from 3 States registered for the training out of which 23 participants successfully completed the training programme. A compendium of articles, presentations related to the relevant topics covered during the course, apart from the copies of the presentations made by the experts provided in soft copy to each trainee as part of the training kit by the Academy.

Overall impact of the training was positive and the feedback and high rating from the participants corroborates the assessment of the organizers. The training programme was very well appreciated by the participants who also requested for more of such training programmes in future.









