Annexure-A

The objectives, description, eligibility criteria for nomination etc. for the award is as -under: -

Objectives: -

- (a) Encourage Officer Trainees of State Forest Service (SFS) to develop a passion for wildlife management and conservation in their career.
- (b) Motivate the SFS Officer Trainees to develop knowledge and skills in wildlife that would ultimately result into better management of wildlife and wildlife habitats within the area of jurisdiction wherever they are posted after passing out from the Academy.

Eligibility Criteria and guidelines: -

- (i) Highest combined marks obtained by an Officer Trainee in Ecological Census Techniques Field Exercise and an essay competition on any contemporary topic on Wildlife Management and Conservation in India. The essay would be evaluated out of 100 marks.
- (ii) The Officer Trainee should have the minimum attendance of 80 per cent in the above-mentioned subject and minimum of 90% attendance in Ecological Census Techniques Field Exercise as specified in Rule 19 of the Entrance and Training Rules for SFS Officers 2004. In case there is a tie between two or more Officer Trainees based on the above criteria, the Officer Trainee with highest conduct marks among the tied Officer Trainees will be selected for the Award.
- (iii) The said award is purely for academic excellence restricted to Officer Trainees of CASFoS Dehradun only and is not of national nature.
