Workshop Coordinator's Report

Three days training workshop on "Human- wildlife Conflict Management" for the In-service Indian Forest Service (IFS) officers was organized by Central Academy for State Forest Service (CASFOS), Dehradun, in pursuance of MoEF&CC letter F.No. 19-7/2023-RT dated 26 October 2023. The training workshop was conducted from 06th to 08th December 2023.

The objectives of the training program were knowledge sharing on best practices in Human-Wildlife Conflict Management across the country, exploring innovative approaches for problem analysis and workable solutions, and understanding Legal aspects of conflict mitigation. Interactive learning between eminent resource persons from across the country and participants resulted in substantial upgradation of the participants understanding of the subject and its practical execution in the field. Following were the key topics covered during the workshop:

- Role of Technology in Tiger Conflict Management
- Managing Monkey Menace- Case study from Himachal Pradesh and Forest Department's Perspective
- Green Infrastructure for Human-Wildlife Conflict Mitigation/ Adaptation
- From Conflict to Co-existence
- Managing Stress in wild animals during Rescue Situation
- Panel discussion on the subject

The participants were taken to Rajaji Tiger Reserve, Uttarakhand, where they interacted with the team of the Reserve to understand practical issues in managing Human-Wildlife Conflict situations and the impact that linear infrastructures like Railways and Roads have on wildlife population and overall ecology.

The training workshop concluded with a panel discussion session chaired by eminent personalities of the subject in which the participants enthusiastically put forth their views and experiences on the subject.

The academy shared all the resource material to participants through online mode and pen drives and also shared with them the details of participants and resource persons.

The Academy tried its best to rope in resource persons for best practices and case studies across the country on the subject, but due to administrative constraints, it was not possible for the resource persons to join the training program.

Overall, the training program was rated highly by the participants and found to be successfully conducted by the Academy.

Proceeding of the Training Workshop

As per the schedule of workshop, following topics were taken up on the subject:

- 1. Role of Technology in Tiger Conflict Management
- 2. Managing Monkey Menace- Case study from Himachal Pradesh and Forest Department's Perspective
- 3. Green Infrastructure for Human-Wildlife Conflict Mitigation/ Adaptation
- 4. From Conflict to Co-existence
- 5. Managing Stress in wild animals during Rescue Situation

Apart from this, doubt clearing, knowledge sharing, and interactive learning was facilitated during the workshop, so that participants from various level of experiences can learn from each other, the best practices of dealing with the issue of Human-Wildlife conflict management.

The first day had sessions which intended to give participants a holistic view of the issues and then take them though the advanced technological means of handling the situation. Whether it is sugarcane tigers in Uttarakhand/ Uttar Pradesh or the monkey menace (urban areas, orchard, and farms) of Himachal Pradesh/ Uttarakhand, they have been dealt with by using unique methodologies which includes modern tools like drones, surgical techniques involving use of robotics.

The second day was about exposing the participants to field realities and showing them about the conflict management infrastructure and setup at field level. The visit and interaction with Rajaji Tiger Reserve team benefitted the participants a lot as many of the participants themselves are dealing with such problematic situations and trying to find workable solutions. Rajaji being close to Dehradun, is at the forefront of coming up with new ideas of tackling these situations in the field. Insight into the Elephant conflict mitigation strategies being practiced by Indian Railways and the Rajaji Tiger Reserve management was given.

Third day of the workshop focused on giving the participants, best possible learning on the subject by eminent managers from the field, both serving and retired on strategies for peaceful coexistence from Conflict situations. The day concluded with a panel discussion chaired by a senior retired IFS officer. All the aspects of HWCM like capacity building of staff, managing stress in wild animals during rescue situations, managing animals which have strayed into cities, coordination with district authorities, etc. were discussed in detail during the session.

Following are the key outcomes/ recommendations from the workshop:

- Transit treatment center/ rescue center Creation of additional infrastructure for keeping the problem animals at circle level.
- Multipronged approach to conflict management Involving modern technologies along with stakeholders' participation through awareness generation, capacity development and people centric animal friendly approach.
- Capacity building of staff Quick response teams in handling conflict situation
- Enhancing interdepartmental coordination Awareness about human wildlife conflict aspects at district level authorities
- Appropriate policy formulation in conflict prone areas Ex-gratia, priority to sugarcane farmers adjoining PAs in sugar factories.
- Skill development and alternative livelihood programs Priority at district level to be given to forest fringe villages.


