In this regard, I am directed to convey the approval of the Competent Authority for the delegation of financial powers to the Director, Directorate of Forest Education, Dehradun as revised given below :

S.No.	Item of Expenditure	Financial Powers proposed to be delegated
1	Sanction of Minor works (original)/ additions/ alterations to each case. a) Residential b) Non-residential	(a) Up to Rs. 1.00 Lakh per annum in each case. (b) Up to Rs. 5.00 lakh per annum in each case. Both (a) and (b) subject to provision of Rules 133 (2) of GFR 2017 for Minor Works executed through CPWD
2	Publication/ Printing and Binding	Upto Rs.1,00,000/- per annum subject to the conditions that invitation of quotations from approved/selected firm and awarding the work on competitive rates. The expenditure being within the sanctioned budget. Further subject to the condition at S.No.14 & 15(i) & (ii) of the annexure to Schedule-V of DFPRs.
3.	Power to incur Miscellaneous Expenditure on light refreshment served during meeting/ conference/ seminars/ workshop/ convocation etc)	Upto Rs. 50,000/- per annum in each case subject to the ceilings imposed vide the orders issued by the Deptt. of Expenditure (M/o Finance) from time to time. The latest instructions relating to austerity measures/expenditure management/rationalization of expenditure issued by the Ministry of Finance from time to time may be strictly followed.
