New Delhi Municipal Council proposes to fill up 01 post of Chief Engineer (Electric) on deputation basis. The pay scale, educational qualifications, eligibility criteria etc of the post as per extant Recruitment Rules is as follows:-

1. Pay Level

Pay level 14 as per 7th CPC pay matrix.

2. Eligibility

Officers in the organizations under the Central Government / State Govts. /UT's:-

- A. (i) Holding analogous posts on regular basis; OR
- (ii) With 03 year's regular service in posts in the scale of pay of Rs. 1,18,500 - 2,14,100 level 13 in 7th CPC pay matrix or equivalent; OR
